ACR Paint & Stain Remover is specifically created to effectively remove all types of water-based paints, oil-based paints, and permanent markers from almost any surface. ACR Paint & Stain Remover can remove multiple layers, and in most cases, with one application. ACR Paint & Stain Remover is ready to use as packaged and does not require any mixing.

NOTE: Test ACR Paint & Stain Remover on all plastic surfaces prior to use.

ACR Paint & Stain Remover is a biodegradable product, however the resulting sludge or waste should be disposed of according to local regulations.

SHELF LIFE & STORAGE

Containers should be sealed and kept in a cool dry location. Avoid prolonged exposure to direct sunlight. If properly maintained this product has a shelf life of one (1) year.

DIRECTIONS

- 1. For best results, use at temperatures between 50° F. and 90° F. Do not allow to freeze as product will lose some of its effectiveness.
- 2. Shake or agitate contents for at least one (1) min prior to application, and occasionally during use.
- 3. Use a sprayer to evenly apply a liberal coat of ACR Paint & Stain Remover to the targeted area.
- 4. Allow remover to work. The longer it sets, the less work for you. Typically from 15 minutes to 3 hours, longer for heavy or old paint or paint stains. Product has a 12 hour wet time.

WARNING: Longer soak times may cause the remover to penetrate deeper than intended.

- 5. Use brush, putty knife, rag, scouring pad, or scrubber for removal.
- 6. Flush surface with soap and water to neutralize the effects of the product. If product is not neutralized, it will continue to work and may damage the surface.
- 7. Before disposal, wash rags in soap & water and dry in a well-ventilated area. Paint residue-soaked rags can cause spontaneous combustion if not handled properly.

NOTE: TechCrete warranties require the use of this product or one of the many ACR products. Chemical cleaning may require multiple applications and the use of different products to achieve a clean surface. Certain types of cleaning equipment may improve performance and speed of application. When applying chemical cleaners, contact the Technical Department for a list of approved equipment and cleaning methods.
